PLEASE READ THE RULES CAREFULLY

THE GCCF RULES THAT NO EXHIBIT MAY BE ENTERED FOR COMPETITION TWICE IN 13 DAYS. THIS RULE INCLUDES ALL OTHER CATS AND KITTENS FROM THE SAME CATTERY/HOME.

RULE 3:- In order to exhibit in any show held under G.C.C.F. licence, the Registered owner/s must complete the official entry form for the show and abide by and subscribe to the following declaration:

- a) I/we am/are the registered owner/s of the cats and/or kittens named on this form and I/we agree to be bound by and submit to the Constitution and Rules of the Governing Council of the Cat Fancy presently in force and to any additional rules formulated specifically for this show, provided only that the latter do not conflict with the former. And/or I/we shall have applied for registration/transfer at least 10 days before the show.
- b) No cat owned by me/us or living at the same address will be exhibited at or entered for any show or public exhibition held less than thirteen days prior to or following the date of this show/exhibition.
N.B. The owner of a cat is the person so named in the GCCF register (Section 4 Rule 1b).
- c) (1) In the event of ear mite infestation being diagnosed in my/our cattery/household by a Veterinary Surgeon, no cat owned by me/us or living at the same address will attend any show/exhibition until such time as all cats owned by me/us and/or living at the same address have been examined by a Veterinary Surgeon and pronounced free from ear mite infestation.
(2) In the event of ringworm infection being diagnosed in my/our cattery/household by a Veterinary Surgeon I/we will inform the G.C.C.F. Office and neither I/we nor any cat owned by me/us or living at the same address will attend any show/exhibition until a Clearance Certificate as required by the G.C.C.F. has been obtained.
(3) In the event of any other infectious disease, with the exception of Feline Leukaemia Virus, Feline Immunodeficiency Virus or Feline Infectious Peritonitis, being diagnosed by a veterinary surgeon in my/our cattery/household, no cat owned by me/us or living at the same address will attend any show/exhibition until at least one month after all cats owned by me/us and/or living at the same address have been examined by a veterinary surgeon and pronounced free from any evidence of the disease in question.
(4) Cats showing a positive reaction to the Feline Leukemia Virus blood test or the Feline Immunodeficiency Virus blood test must not be shown. NB. Council strongly recommends that all cats should be tested regularly. Vaccination against Feline Leukemia is also available.
(5) Following a veterinary diagnosis of Feline Infectious Peritonitis in my cattery/household no cat will be shown until at least one month after the death or completion of treatment for any sick cat. (Added 28.10.23.)
(6) No cat from my cattery/household will be shown for at least one month after I have imported a cat from any overseas area defined by the GCCF Veterinary Advisory Committee as having a particular risk of infection. (The current list of areas is available from the GCCF website and Office). (Added 28.10.23)
N.B. Council strongly recommends that all cats should be tested regularly. Vaccination against Feline Leukaemia is also available.
- d) I agree to abide by any decision regarding rejection made by the examining Veterinary Surgeon.
- e) To the best of my knowledge, the cat/s entered for this show has/have not been subjected to any surgery to correct any defect listed in the G.C.C.F. Standards of Points.
- f) If the registered owner is aged under 18, the declaration must be countersigned by a parent/guardian

- 2 USE BLOCK LETTERS PLEASE.
- 3 If the age, pedigree or breeders name are not known, the word 'UNKNOWN' must be written in the space available
- 4 Please state clearly the sex of exhibits ie M (Male), F (Female), MN (Male Neuter), FN (Female Neuter).
- 5 A Standard of points must be sent with all assessment exhibits.
- 6 All exhibits must be accompanied by the owner or the owners representative.
- 7 Please note that in addition to the classes you have entered, your cat may also be handled for the purpose of assessing candidates in the GCCF judge appointment scheme
